Mayor Rinker administered the oaths of office to Council President Buckholtz and Council President Pro Tem Tom Marrie.


ANY OTHER MATTER THAT MAY COME BEFORE COUNCIL


ADJOURNMENT

Mrs. Mills, seconded by Dr. Parker, made a motion to adjourn.


The meeting adjourned at 7:25 p.m. The next Council meeting is scheduled for Tuesday, January 17, 2012 at 8:00 p.m.
