**AN EMERGENCY ORDINANCE ESTABLISHING
THE PARKVIEW SWIMMING POOL EMPLOYEES SALARY
FOR THE 2011 SEASON**

WHEREAS, the Parks and Recreation Director has recommended a salary range, per hour, for certain positions that will be used in servicing the Parkview Swimming Pool in the Village of Mayfield during the 2011 pool season.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:


SECTION 1. The following positions and salary ranges, per hour, are established for the 2011 pool season at the Parkview Swimming Pool in the Village of Mayfield:

Pool Manager	\$12.00-19.00
Assistant Pool Manager	\$10.00-17.00
Snack Bar Manager	\$10.00-18.50
Snack Bar Supervisor	\$ 9.00-13.00
Learn to Swim Coordinator	\$ 8.50-16.00
Head Lifeguard	\$ 8.00-17.00
Lifeguard	\$ 7.65-15.00
Lifeguard with WSI (Water Safety Instructor)	\$ 8.50-16.00
Head Cashier	\$ 8.00-14.00
Cashier	\$ 7.40-11.00
Checker/Pool Attendant	\$ 7.40-11.00
Pool Maintenance	\$ 7.40-14.00
Snack Bar Attendant	\$ 7.40-12.00
Head Coach	\$350.00 - 700.00 per season
Assistant Coach	\$300.00 - 500.00 per season
Special Program Water Instructor	\$200.00 - per season or negotiable

SECTION 2. 
