## A RESOLUTION OF CONGRATULATIONS TO DR. PHILLIP PRICE OHIO'S SUPERINTENDENT OF THE YEAR






**SECTION 4.** This resolution shall become effective upon its adoption by Council and the signature of the Mayor, or as may otherwise be provided by law.
