CHARTER REVIEW COMMISSION - A NEW COMMISSION MUST BE APPOINTED EVERY 5 YEARS PER CHARTER AMENDMENT PASSED IN NOVEMBER, 1994.

"In January, 2005, and each five years thereafter, the **Mayor and each member of Council** shall appoint one elector each (for a total of 8), who shall be electors of the municipality holding no other elective office, in the government of the municipality, as members of the Charter Review Commission." (Ordinance also outlines specific duties of CRC members.) While there is no exact term specified in the Charter, it states that "the appointees must review the Charter within 5 months of appointment and then hold a review session with Council." A Charter Review Commission was appointed in January 2015. **The next Charter Review Commission must be appointed in January 2020.**
