Subject: 2019 Fireworks Provider

Request:

After valuation of three Fireworks proposals (see attached) it was recommended by the Parks and Recreation Entertainment Committee to accept the proposal from American Fireworks in the amount of \$20,000 for 2019 Fireworks display on June 29, 2019 with a rain date on June 30, 2019. American Fireworks was selected based upon the following criteria:

Evaluation Criteria

Proposals will be ranked based upon the merits of the written proposal and the qualifications and experience of the firm or consultant team. Each reviewer will award a score based on a 100-point total as follows:

- Responsiveness: The Village will consider the materials submitted by the service provider to determine whether the service provider is in compliance with the RFP. (10)
- Creativity, variety and content of fireworks display. (20)
- Price. (40)
- Responsibility: The Village will consider the materials submitted by the service provider and other evidence it may obtain to determine the company's ability and history of successfully completing contracts of this type, past performances with the Village, meeting projected deadlines, experience in similar work, and ability to accept the Village's standard terms and conditions. (30)
