Proposed Tax Levy
(Renewal)
Village of Chagrin Falls

A majority affirmative vote is necessary for passage.

A renewal of a tax for the benefit of the Village of Chagrin Falls for the purpose of current expenses at a rate not exceeding 5.5 mills for each one dollar of valuation, which amounts to 55 cents for each one hundred dollars of valuation, for five years, commencing in 2019, first due in calendar year 2020.

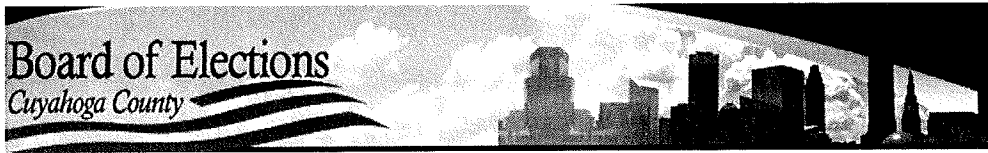

- Bratenahl (1 precinct)
 - Issue 5: Bratenahl
 - Proposed Income Tax (Additional) - 0.5% levy increase on income, to a rate of 2%; effective June 1, 2019.
- Broadview Heights (14 precincts)
 - Issue 6: Broadview Heights
 - Proposed Zoning Amendment: Rezone certain property located on the North side of Route 82 between Seneca Boulevard and Oakwood Trail from present A-1 (Single Family Dwelling) to Special Planning District Zone B.
- Brooklyn (8 Precincts)
 - Issue 1: Brooklyn City School District
 - Proposed Tax Levy (Additional): 6.9 mills for the purpose of avoiding an operating deficit, for ten years.
- Chagrin Falls Village (3 precincts)
 - Issue 7: Chagrin Falls Village
 - Proposed Tax Levy (Renewal): 5.5 mills for the purpose of current expenses, for 5 years.
- Euclid (39 Precincts)
 - Issue 2: Euclid Library District
 - Proposed Tax Levy (Renewal): 5.6 mills for the purpose of current expenses, for 5 years.
- Mayfield Village (4 precincts)
 - Issue 8: Mayfield Village
 - Proposed Zoning Amendment: changing the zoning classification of six permanent parcels on Highland Road.
- Oakwood Village (5 Precincts)
 - Issue 9: Oakwood Village
 - Charter Zoning Amendment: permitting the construction and operation of video and audio recording, production and editing facilities, helicopter landing and take-off pads accessory to such uses, and passive parks and nature preserves in a certain area.
