**AN EMERGENCY RESOLUTION
AUTHORIZING MAYFIELD VILLAGE TO ACCEPT THE BID OF
AMERISCAPE LAND DESIGN INC. IN AN AMOUNT NOT TO EXCEED \$28,200.00
FOR THE 2019-2020 SENIOR SNOW REMOVAL PROGRAM**

WHEREAS, based upon recommendation, it has been deemed in the best interest of the health, safety and welfare of all Village residents and inhabitants to continue the Senior Snow Removal Program for the 2019-2020 season; and

WHEREAS, based on the scope of the Senior Snow Removal Program three snow removal contractors will be needed; and

WHEREAS, the bids for the aforementioned project were received, opened and tabulated as per published notice on July 26, 2019; and

WHEREAS, the bid of Ameriscape Land Design Inc. was one of the lowest and best bids received; and

WHEREAS, said bid was in the amount of \$235.00 per driveway for three sections or approximately 120 driveways for a total amount not to exceed \$28,200.00 for the 2019-2020 season; and

WHEREAS, the Village Senior Program Coordinator has hereto reviewed the bids and recommended that the City Council approve and accept the aforementioned bid for said project.

BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

SECTION 1. The Council of Mayfield Village hereby accepts and approves the bid of Ameriscape Land Design Inc. in an amount not to exceed \$28,200.00 and the contract is hereby awarded to Ameriscape Land Design Inc.

SECTION 2. The Council of Mayfield Village does hereby direct the Mayor and President of Council to enter into a contract with Ameriscape Land Design Inc. for the 2019-2020 Senior Snow Removal Program in the Village.

SECTION 3. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meeting of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including requirements of Section 121.22 of the Ohio Revised Code.

SECTION 4. This resolution is hereby declared to be an emergency measure immediately necessary for the preservation of health, safety and welfare of the residents of Mayfield Village, Ohio, for the reason that public bids must be awarded within sixty (60) days of the bid opening and it provides for necessary services to the elderly and disabled residents of Mayfield Village. It shall, therefore, take effect immediately upon the passage by the affirmative vote of not less than five (5) members elected to Council and approved by the Mayor or otherwise at the earliest time allowed by law.


