**A RESOLUTION REQUESTING
THE CUYAHOGA COUNTY FISCAL OFFICER
TO ADJUST THE AMENDED OFFICIAL CERTIFICATE
OF ESTIMATED RESOURCES FOR 2014**

WHEREAS, the Amended Official Certificate of Estimated Resources for 2014 for Mayfield Village is to be adjusted under “Other Sources” to reflect the 2014 budget; and

WHEREAS, the Council has found and determined that the adjustments should be made and forwarded to the Cuyahoga County Fiscal Officer.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF MAYFIELD VILLAGE, OHIO, THAT:

SECTION 1. The Finance Director for Mayfield Village be and is hereby requested, authorized and directed to immediately forward to the Cuyahoga County Fiscal Officer the adjustments to the Amended Official Certificate of Estimated Resources for 2014 for Mayfield Village with “Other Sources” to be adjusted to reflect the amounts as listed in Exhibit A attached hereto.

SECTION 2. The Clerk be and is hereby authorized and directed immediately to forward a copy of this Resolution to the Cuyahoga County Fiscal Officer.

SECTION 3. The Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

SECTION 4. This Resolution shall become effective upon its adoption by Council and signature of the Mayor, or at the earliest time permitted by law.
