Our partnership with Rookie Sports has been successful and popular with the community in providing programs for ages 3-10. This has allowed the Parks and Recreation Department to expand youth programming while increasing revenue. In 2019, Mayfield Village received 25% of the program revenue which 2019 totaled around \$2900. In 2020, we plan to increase and expand the programming with Rookie Sports. After review of our 2019, I estimated that our partnership with Rookie Sports will generate around \$22,000 in new programming which the Village will receive 25% of this revenue in an amount of \$5500, and Rookie Sports will receive approximately \$16500.00
